Florence Road Water Supply


Problems about the Florence Road site water leak has hopefully been resolved with the laying of a new water main into the site and the provision of a new stand pipe for use by the allotment plot holders.



Dogs

Complaints are still being received from allotment holders about dogs being brought onto allotment sites particularly when dogs are roaming free and dog fouling. There is no reason for dogs to be brought on to allotment plots so please leave your dog at home while visiting your allotment plot.



Rainwater Harvesting

There are several ways of doing this with a number of good offers on the internet for water butts and harvesting equipment. However, a word of warning! Make sure that the water butt that is ordered is a correct one and not a general 'white' or similar storage container. Some of these have been used for other uses and can contain contaminated material or be a contaminant in their own right. The moral of this story is to be cautious about what you buy!
