The Committee noted a copy of an email received from the Property Manager explaining the historical background of the previously proposed name of Harington Lodge.

The Chairman commented that it might be of interest to local people to know the origin of the name in the form of a plaque for example.

After careful consideration the Committee RESOLVED to support the name "Harington Lodge". The Property Manager would be advised accordingly.
