Mrs Whitty updated members on the following:

Mrs Whitty advised members that Chichester District Council were looking into the unauthorised parking in the field at Prebendal School and may issue a Breach of Condition Notice.

53 BUILD A BETTER A27 - NOTIFICATION OF MEETING TO BE HELD ON 25 SEPTEMBER 5.30-8.30PM, THE ASSEMBLY ROOM, CHICHESTER

The Chairman reminded members of a Community Workshop Meeting being held on 25 September 2017 at which MP Gillian Keegan would attend. Members noted that it had not been possible to secure a six month extension to the 30 September 2017 deadline for funding. The District Council would be holding a Special Meeting of Council on 27 September 2017 at which the A27 Chichester Bypass Improvement Scheme would be debated.

RESOLVED to note the current situation.

54 SOUTHERN WATER'S PROPOSAL TO BUILD A 10KM SEWER PIPELINE FROM THE WEST OF CHICHESTER TO THE TANGMERE WASTEWATER TREATMENT WORKS UPDATE FROM THE PRESENTATION GIVEN BY SOUTHERN WATER ON 13 SEPTEMBER 2017

The Committee briefly discussed the pre-application information from Southern Water including the need for the works, the route, construction methodology, planning process and likely timescales. A leaflet, describing the proposal, was circulated to members. It was noted that the works would probably occur from east to west due to the order in which major new developments were likely to come forward. Concern was expressed about whether the proposed 12 inch diameter of the pipeline would be sufficient.

It was RESOLVED to note that a planning application would be forthcoming in November 2017.

55 STREET NAMING AND NUMBERING PROPOSALS - TO CONSIDER APPLICATION RECEIVED FROM COUNCILLOR JULIAN JOY

Councillor Joy declared a Personal Interest in this item and left the meeting whilst this matter was discussed.

The Committee were asked to consider Street Naming Proposals received from Councillor Julian Joy. The application related to two new build semi-detached houses on land adjacent to 19 Orchard Street, Chichester. The following street numbers/names had been proposed: No's 1 and 2 Joy Lane, Orchard Lane, Park Way or Field View.

The Committee RESOLVED to support No's 1and 2 Joy Lane. The Property Manager would be advised accordingly.

Mrs Whitty reminded members of the background to this Appeal.

The Committee RESOLVED to note that the Appeal had been partially allowed; the hanging sign was allowed but the fascia and other signs were found not to be acceptable and this part of the appeal was dismissed.
