93 PLANNING CONTRAVENTIONS

The Planning Adviser updated members on the following:

(i) Flames, 10-11 St Pancras, Chichester

A Listed Building Enforcement Notice had been served by Chichester District Council for unauthorised alterations and illuminated signage to the front/southern elevation of the building and the date for compliance was 7 February 2018. It was noted that the glazing bars had been restored but the illuminated signage remained. The Planning Adviser would contact the Enforcement Team at Chichester District Council.

(ii) 13 Parchment Street, Listed Building

Unauthorised installation of 3 uPVC windows. Listed building Enforcement Notice allows until 29 May 2018 to resolve the matter.

(iii) Prebendal School, parking in field (Minute 52 refers)

Had been given 14 days notice to remove unauthorised signage from the Listed Building.
