The Planning Adviser said that Flames had submitted another planning application for signage.

102 APPLICATIONS FOR PLANNING PERMISSION

(i) CC/17/03136/FUL

19 Southgate Chichester PO19 1ES Formation of 9 no. dwellings through creation of 2nd floor and change of use of part of ground floor and 1st floor. Various external alterations including location increases in height of roof and changes to its form, 1st floor infill extension and the introduction of new and changes to existing door and window openings. (Minute 85(iii) refers) The Planning Adviser said that she had recently met with the Planning Director of Jasper Management Group Limited (developer) to discuss this application. Members were reminded that this application had been previously discussed at their meeting on 13 December 2017 when an objection had been raised.

The Planning Adviser then gave a short presentation outlining the changes that had been incorporated which attempted to alleviate the noise disturbance issues and the issues relating to site layout including parking, loading and waste and recycling storage.

The Chairman then introduced Ms Lotte Hirst of Jasper Management Group Limited (developers) to the meeting.

Ms Hirst addressed the meeting and gave a short presentation in support of this application. She explained that steps had been taken to address the noise issues. She then invited questions from members.

The Chairman thanked Ms Hirst for her presentation and after some discussion it was RESOLVED to raise No objection subject to a planning condition being imposed requiring noise mitigation in line with the details outlined in Appendix D of the revised noise report.

103 STREET NAMING AND NUMBERING PROPOSALS - TO CONSIDER AN APPLICATION RECEIVED FROM 77 PROPERTY LIMITED

The Committee were asked to consider a street naming proposal received from 77 Property Limited. The application related to a new block of 4 apartments at 8 Fordwater Road, Chichester. The proposed names were: "Fordwater Gardens", "Fordwater House", "Fordwater Manor"

After discussion, the Committee RESOLVED to support the name: "Fordwater Gardens". The Property Manager would be advised accordingly.
