Chichester Community Arts Forum Update

At the recent Chichester Community Arts Forum meeting (14 November), members discussed challenges faced by local arts and community groups, particularly around the high cost of space in the city and the need for affordable, temporary and multipurpose spaces and storage. To address these barriers, there was a proposal to transition the Arts Forum into a Charitable Incorporated Organisation (CIO).

Establishing the Forum as a CIO, under the name "Chichester Community Arts Forum," would provide additional benefits, including tax reliefs and reduced business rates, making it more affordable for groups to rent space. A CIO structure would also enable the Forum to apply for more grant opportunities, such as those from Arts Council England and the National Lottery, with increased chances of success.

The next steps will involve consulting with Selsey Arts Dream CIO, a similar organization in Selsey, to learn from their successful model. Following this, a broader discussion will take place regarding trustee roles and community management for a future CIO structure.

It is important to note that some of the CA Workers weekly hours are spent on casework once they have had their initial meeting with a client.

Charity Forum

To support the Local Charities in the City the working group agreed to holding quarterly meetings to provide training, network opportunities, a space to hear what charities need and inform them of City Council initiatives and events e.g. grants, parish meeting etc. Three forums have been held, the first one informed the sector about Clio3, which is a WSCC online information platform, the second one provided training on measuring impact and the third one training on marketing. Around 18 to 20 charities attend.

One of the major findings from the charity forum is around the need for a community space. JB came to the last meeting to consult with organisations so he could start analysing what the needs of the groups were and add these findings to his feasibility report.

Community Hub

Sarah Adams the Operations Manager from Chichester District Foodbank came to one of the working group meetings to make a presentation and propose the City Council and Foodbank run a pilot Community hub where members of the public could drop in and receive help from local organisations e.g. Southern Water, Citizens Advice, Supporting You, Home Start and so on.

The event happened on the 24th September and was led by the Foodbank in the Assembly Room. 18 organisations attended. Unfortunately, despite advertising the event, footfall was lower than hoped, 20 people dropped in. A survey showed that the people who attended found the event very valuable.

Feedback from the organisations suggested The Assemble Rooms was not the right venue due to accessibility as users found it daunting and overwhelming to enter, but a quarterly event in alternative venues would work.

Further feedback from organisations was that we should consider running an outdoor street market, but for charities rather than for businesses. This was also picked up in the High Sheriffs community meetings with local organisations. This is something the working group would like to investigate alongside a coffee and cake support drop in hosted in the portico when the weather improves.

- UK Harvest events attended giving advice, help and support to struggling households. Help with cost of living advice and signposting to various agencies which is needed more than ever as so many have lost their Winter Fuel Allowance.
- UK Harvest have now changed from weekly to fortnightly, the Residents Association and I trialled a drop in until the end of Sept, but have now discontinued it due to lack of numbers.
- Talks and advice given on the latest scams, particularly the texts supposedly from Royal Mail/Evri about undelivered parcels and wanting bank details. There's also a new one saying they are a single mother with children and have no food, pulling at heartstrings and asking for money.
- Elderly resident aged 94 almost scammed of £300 by a man saying her guttering needed replacing. Quick action by neighbours resulted in him running off and driving the wrong way down a one way street to escape. Reported to police, advice and welfare checks carried out. I also delivered window/door stickers about cold callers for everyone in the street.
- Cyclists and electric scooters continue to be a problem in pedestrian areas of Chichester and through Parklands. I stopped a man on a scooter riding on the pavement with a small child balanced on the front. He didn't appreciate my advice on regulations and safety of either his child or pedestrians.
- Visited the older people's club to talk about the 'Message in a Bottle' scheme which is run by the Lions Club. Gave out 15 bottles. I have also been urging residents to check whether they are eligible for Pension Credit.
- Very pleased to say that the elderly lady I helped to complete an extremely long and complex Attendance Allowance form has now had her application accepted. This will make a considerable difference to her so she can afford to take taxis and get help around the house as she has been struggling both physically and financially.
- I have been helping with cover for Bracklesham and East/West Wittering until the new Warden starts there imminently. I have also done some patrols in the City Centre since our Senior Warden sadly passed away suddenly. Helped one lady who had fallen in East St and waited with her until the ambulance arrived. <u>Chichester City Ambassador Operational Report</u> <u>November 2024</u>

Please find below an overview of the Chichester Ambassador service level performance.

Key stats from 26TH August 2024 to 24th November 2024

- 363 x high visibility patrols conducted in the individual shops / locations
- 251 direct business interactions introductions or support
- Attendance or support at **34** shoplifting incidents
- Attendance or support at 22 Anti-Social behaviour incidents
- Gave Assistance to the Public through advice or help **37** times
- Welfare checks on shop staff post shop lifting incidents -26
- DISC reports submitted 8
- Attended other miscellaneous incidents 21

Key points

- Ambassadors are now out in the city for 5 x 6 hour shifts a week, as opposed to 3 shifts a week. This has been funded from the UK SPF fund and Chichester BID revenue budget. This change to the work pattern commenced 11th November 2024 and will continue until the end of March 2025. Budgets will be reviewed again at this point to see if this extended service can be continued, as there is a definite need for this increased coverage.
- In October, a meeting was held with Sergeant Ebou Faal to discuss local issues and how we can improve communication with the police. This meeting is to be scheduled regularly, hopefully every 3 months.
- A meeting between the Ambassadors and ChiBAC is to be set up for early December, to discuss how they can be more effective in bridging the gap with retailers and how we can help in supporting the retailers to increase their crime reporting rate.


- 1. Regular patrols at regular hot spots for example Cathedral Green







It's our role as your fire and rescue service to understand and manage the risks in our communities.

This helps us to establish where we need our staff and resources, so we can respond to high-risk incidents and plan how to deliver our vital prevention and protection work to help keep communities safe.

We have a statutory duty to prepare a Community Risk Management Plan (CRMP) which sets out the steps we take to try and prevent emergency situations from arising, as well as the measures we have in place to respond to an emergency situation.

Our current CRMP, which was launched in 2022 and runs until 2026, sets out five Strategic Priorities that we have committed to delivering against:

- 1. **Preventing fires and emergencies from happening.** Keeping people safe from vulnerable situations and helping people and communities to fulfil their potential.
- 2. Protecting people, firefighters and property by making buildings as safe from fire as they can be. Keeping people safe from vulnerable situations and help promote a sustainable and prosperous economy.
- 3. **Responding to fires and emergencies quickly and effectively.** Keeping people safe from vulnerable situations and helping people and communities to fulfil their potential.
- 4. **Have a safe and valued workforce.** This includes developing our cultural values and behaviours as well as supporting the health and wellbeing of our staff.
- 5. **Making best use of resources**, including our buildings and vehicles, making sure we remain up-to-date with the latest technology.

Before we begin planning our next CRMP, which will run from 2026–2030, we want to hear from you about the risks in your communities that concern you the most.

This will help us make sure that we have the greatest understanding of the risks and challenges that exist within our county and allow us to plan for the future to ensure that we have the right resources in the right place at the right time to help keep you safe.

We have prepared a short questionnaire that sets out some of the key risks within our county, and would really welcome your input to help us understand the issues that are most important to you.
