Reinstatement of the much-valued Junior Citizen child safety programme later in the academic year, with provisional dates in April or June.

Junior Citizen is a multi-agency initiative designed specifically for Year 6 pupils, recognising the importance of their transition to secondary school. The programme equips children with essential skills, knowledge, and confidence to stay safe, make informed choices, and understand the consequences of risky behaviours—all within a structured, interactive learning environment.

A key strength of the programme is the direct engagement between pupils and the professionals delivering each session. This interaction helps build rapport, fosters a deeper understanding of the roles and responsibilities of each agency, and encourages children to consider future career paths. It also prompts reflection on how individual behaviour affects public services and the wider community, contributing to efforts to reduce anti-social behaviour in our towns and cities.

Joint work with Meadow Blue Community Energy

We progressed the Meadow Blue Community Energy commissioned work and managed the Meadow Blue VCSE Eco funding. Via this fund, **Chichester Community Development Trust secured 10k for their bicycle recycling project.**

We linked our members to Meadow Blue and the image below shows the installation of a new roof and solar at New Park Community Centre, the first initiative funded via a 'soft' loan.

Equity, Inclusion and Diversity</p> | <p>VAAC'S Values focus on equity, inclusion, diversity, community enrichment, and strengthening VCSE voice.</p> <p>We have a clear purpose - responding to local needs and enabling sustainable change.</p> <p>Two examples of this work are below:</p> <p><u>Ukrainian Community Development Work</u></p> <p>The Ukrainian teenage psychological support group Starshina continued their regular Sunday meetings at The Boys Club in Chichester. They were supported with community group registration and the opening of a bank account. We are now exploring ways to assist the group with volunteer recruitment.</p> <p>In August 2025, we attended an event organised by Roota, a new Ukrainian group. It celebratr Ukrainian Independence Day in Chichester. We facilitated networking with the Ukrainian community in Hampshire as well as other local Ukrainian groups.</p> <p>Volya Art Community group was further supported through the development of the Ukrainian Cultural Festival in Chichester on 15 November. Funding from both Chichester District and Chichester City Councils was secured for the event.</p> |



The festival was a great success and attracted a record number of visitors.

Disabled People's Initiatives and Access:

Chichester for All

Chichester for All operates as a small steering group, with a wider reference group and attends various strategic meetings. Including CDC Chichester Nighttime Economy Forum and the Parking Forum.

We have also engaged with New Park Community Centre regarding their proposed capital project that will enhance their accessibility.

Chichester ShopMobility

The highlight of this work over the last 12 months was the CCC launch of the Shopmobility scheme by CCC on 2nd May who are now operating a small scale 'shop-mobility' service.



Ramp UP Chichester

We have collated a list of independent city centre businesses who do not have accessible ramps. VAAC hopes to work with Chichester BID to promote the scheme and invite businesses to apply for a ramp.

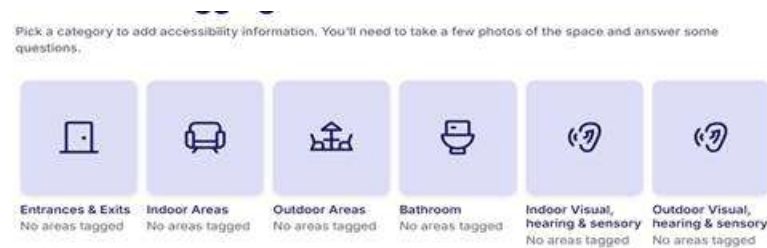
Public transport - disability awareness training

Training was needed for both bus and taxi drivers. However, since bus operator Stagecoach is a national company, and a number of national charities are already in contact with Stagecoach, it was felt that VAAC's work should concentrate on improving disability awareness for taxi drivers.

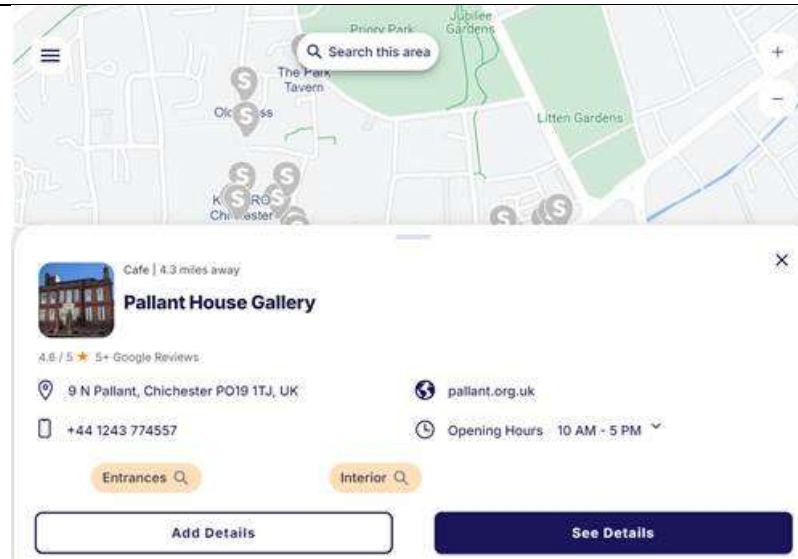
VAAC undertook a consultation to understand how other councils provide disability awareness training and found many now mandate disability awareness training as part of their licensing requirements with most using third party online service providers. We continue to campaign to ensure that the Disability Awareness Training becomes compulsory as part of the license.

Chichester access guide: Sociability

Research was carried out to find a quick and easy accessibility guide. Sociability is a free to download (and use) mobile app (Android and Apple) which allows users to identify accessibility information across six areas.



Business details are listed with information such as opening hours, address, etc.



The data includes photographs and details of internal and external facilities such as entrances.



Sociability is currently populating the site with data for the country's largest cities and towns. Chichester For All has begun to populate the site with information surrounding external accessibility such as entrances, including sensory information.

Chichester's inclusion on this site can be promoted through the local media, local and district council websites, BID and the Great Sussex Way.

West Sussex consultation on Public Realm Autumn 2024

Chichester for All was involved in the consultation to improve the existing public realm within the pedestrian zones of East and North Street. We were pleased with the results of the consultation. As detailed below:

Feedback from Mike Turner, the Chair of the Chichester Boys Club on the VAAC's support with volunteer recruitment:

"Finding new trustees is a real problem relying mainly on personal contacts which by definition are limited. We had been searching for a new trustee/potential treasurer for more than two years without success. When we became aware that VAAC might be able to help we were more than happy to work with them. Firstly, they were very helpful in framing the wording of the 'advert' for the post and secondly for publicising it. Within a matter of only three weeks two people came forward, one of whom met our requirements perfectly. She has now become a trustee and is understudying the current Treasurer with a view to taking over in the near future. By way of a bonus we received details of another person who, after seeing the advertisement, searched our website etc to find out more. She had only recently moved to the area and was not otherwise aware of our existence. After meeting her and explaining that the post was already filled, she expressed interest in becoming a volunteer to help us with our various youth programmes. She has experience in this area and is now fully integrated into the team, making a valuable contribution to our work. We are extremely grateful to VAAC for their help in filling these posts and will not hesitate to make use in the future."

MONITORING REPORT FROM CHICHESTER CINEMA AT NEW PARK LTD

In 2024, the registered charity Chichester Cinema was awarded a three-year community grant of £5k per annum from Chichester City Council. It was agreed that the funding would:-

- Help us to continue creating a thriving and engaged community through our educational and cultural programme, within a warm, safe, welcoming and socially inclusive environment
- Enable us to continue including the city's unique and historic sites and buildings during its annual international film festival, preserving Chichester's heritage and fostering civic pride
- Facilitate reaching out to the audiences of tomorrow by targeting the changing demographic of the city – the new professionals and recent empty-nesters frequenting the new builds
- Help us to target young people aged between 15-25, many of them students, not just to introduce them to the wonderful world of independent cinema, but also fulfilling a key social welfare role as many of them deal with social isolation ignited by the Covid lockdowns and perpetuated by remote working and addictions to handheld devices.

IMPACT OF THE FUNDING

2024

1. £3.5k was spent to improve the safety and access in our cinema by providing handrails on each side of the central auditorium staircase, making the route to each seat so much safer. Since the installation we have had no falls and we have received positive feedback from our patrons. We also put in new safety glass in the box office which incorporates a looped microphone, making our hard-of-hearing patrons feel much more comfortable being able to hear better when booking their seats and we now provide the free use of looped hearing devices for amplified sound in the auditorium for the hearing impaired.
2. We used the balance of £1.5k towards the costs of auditorium hire for performances and technical rehearsals for our Education programme. In 2024 we had planned to do 18 talks for adults and 23 talks for schools but in fact we did 23 talks for adults and 23 talks for schools. We reached 1342 pupils across 8 schools and colleges, spanning all age groups, working with Bishop Luffa Y8 and A Level, Chichester High School Y10 & Y11, Southbourne YR6, Chichester Free School Y9, Fishbourne Primary Y4, Felpham College Y10, Bohunt Liphook Y10, The Regis School YR9, Y12, YR13 and we reached 988 adults across our 23 public, paid talks. In our post event surveys, 100% of attendees say they would recommend our talks to others and we can provide testimonials from teachers should you wish to see them.

2025

1. We requested £1.1k to put towards the erection of heras fencing in Priory Park for our open air screenings during the international festival, and towards the costs of hiring the LED screen and projector which enables daytime projection. Impact-wise, the Festival's open air screenings reached 1700+ people. The grant was also to include the cost of screening

the 1927 silent classic film *Sunrise* in St John's with a live accompaniment of piano, harp, flute and accordion. The latter got a near 100% 5 star rating from our attendees with one patron saying it was one of the best experiences of his life and in all we received almost 80 admissions.

2. £2.1k went towards the costs of auditorium hire for performances and technical rehearsals for our Education programme. In 2025 we did 26 talks for schools and 25 talks for adults. We estimate we will have reached at least reached 1040 pupils by the year end and 1210 adults. In addition to the schools above we are also now working with Oakwood School, The Petersfield School, the University and the College. In addition to the talks they are now bringing groups down for bespoke screenings or just to learn more about what we do and what a rich cultural life they can have if they join us as members.
3. The remaining activity in 2025 focused around the development of FILM CLUB, a new initiative aimed at 15-25 year olds. They can join for £3.50 and thereafter they can see any film each year for just £3.50 and once a month, there is a screening dedicated to them with a slice of pizza thrown in. This monthly screening is designed to get them out of their digs and socialising with like-minded people. As it is a club, they get to see the same people attending and friendships are formed, and importantly, they are given an eclectic array of films, as diverse as Cinema Paradiso, Psycho, Amelie, Pulp Fiction, In the Mood For Love and Blade Runner. For Freshers Week we had fliers made, and pull-up banners, badges and we put Film T-shirts on the staff attending. We now have 84 signed -up members. It is wonderful to see young people experiencing and loving seeing a foreign language film for the first time or discovering Hitchcock! The members also offer volunteering assistance during the Film Festival now and seem to relish feeling part of an exclusive club.

We anticipated spending much more on Freshers Week than we actually did in year 2 but the projection costs for the Open Airs were much higher because our provider had increased the screen size and now charges more. But the provider still remains competitive.

2026

1. £2.3k has been allocated to Education again because this is such an important part of our work, and something we know is unique. Outside of the BFI we do not believe that any other cinema is doing anything remotely on the scale of our educational output.
2. We will continue with Film Club, but we would like the Council's blessing to spend less on Freshers Week (mirroring our spend in 2025), with the balance going on some PR assistance and help with our social media to reach this young audience. The other upside of focusing on Film Club is that it has enabled us to forge new relationships with The Young People's Shop, The Jam Café, Cobnor Activities, Chichester BookFest, and West Sussex Careers Hub etc
3. During this year our emphasis has shifted from wanting to target the new builds to targeting the most disadvantaged members of Chichester's Community and to this end we have been working with the housing associations of Hyde and Clarion and with Community Transport, Home Start, Family Support Work and West Sussex Young Carers to provide free cinema tickets in the run-up to Christmas, and offering free annual memberships to those most in need. We would like to discuss this shift in direction with Chichester City Council when we meet and moving the £0.6k spend from new builds to the disadvantaged.

Annual Monitoring Report for our Multi-Year Grant

The grant was awarded in June 2024 for three years, in order to:

- Enable children from the more disadvantaged schools in Chichester City to have a free farm visit.
- Offer Forest School for schools to reach the most disadvantaged and vulnerable children in the city community.
- Deliver Children in the Community woodland days for local charities and organisations supporting children facing challenges in life.

In the period June 2024 to November 2025, we're delighted to update that:

Farm Visits for Chichester City Schools

We welcomed children from St Anthony's Special School, St Joseph's Infant School, Portfield Primary and Fordwater Special School to the farm. Due to funding from other sources, in this case the Rural Payments Agency, we did not need to use City Council funding for these trips.

Children spend the day on the farm, meet the animals, learn about growing crops and sensitive land management, make butter, try the milk, meet the people who put the food on our table, and think about careers and opportunities in agriculture. They spend time outside and improve their mental and physical health.

Forest School for Chichester City Schools

Children from Bishop Luffa, Chichester High School and St Anthony's Special School have attended weekly as part of their curriculum. This is for children who are struggling with mainstream schooling, or who are at risk of exclusion, or are in some way vulnerable. The benefits of Forest School practice for children are powerful, offering autonomy and agency over their choices, nurturing new

connections, working with adults beyond school or family, and the freedom to try new things while reducing the fear of failure.

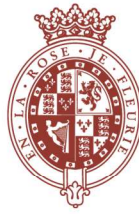
Forest School, while based in the natural environment, develops valuable life skills for those participating, such as decision making, co-operation, socialisation, communication skills, perseverance, working with adults, making positive informed choices and conflict resolution. Drawing on these skills when back in the school environment, the teachers observe children engaging in education which can keep them safe and reduce their vulnerability.

Bishop Luffa said, 'The child-centred ethos of Goodwood has given rise to confidence in some highly complex individuals when little else appeared to work'.

St Anthony's said, 'The Special School said, 'Pupils are particularly motivated to work together to create things like bridges, they are turn taking, co-operating and communicating with each other and reaching decisions without adult support. We have noticed this has strengthened the friendship bonds between them and this has had an impact on them whilst at school too, during social interactions like play times'.

Children in the Community woodland days for Chichester City charities

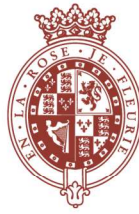
We use our funding and facilities in partnership with local charities, to provide free woodland activity days for children and families facing a challenge in life. In 2025, city-based charities included:

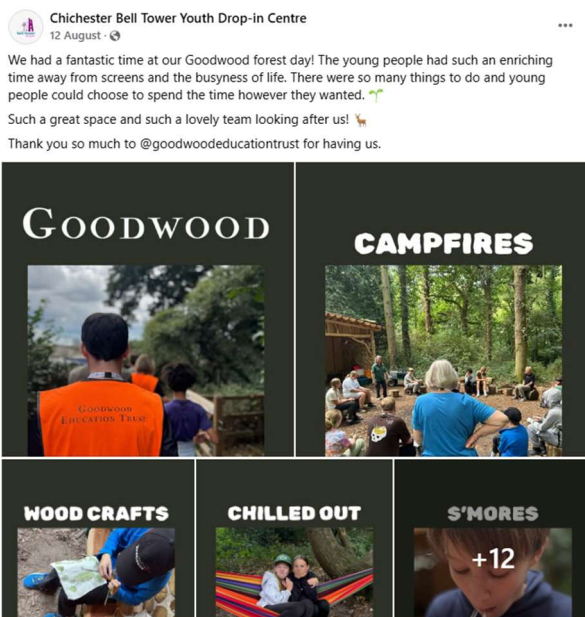

Friends of Chartres:

A short report had been provided. A visit to Chartres is being arranged. The trip to Chartres (30/4 - 4/5) will be followed directly by a trip to Ravenna (8/5), so many members will be travelling directly from one to the other.

Cllrs asked how relationships with local schools were developing?

FoC have made contact with a number of schools but are still finding it difficult to establish a relationship Graham Pound asked if members of the committee could advise him of any contacts they had in local schools.

Cllrs asked if it was a reasonable expectation to build links with local secondary schools?

There have been many problems as schools struggle with resources and the cost of school trips is becoming increasingly prohibitive. Schools do not seem to be interested in building exchange links with schools in Chartres.

Friends of Ravenna

They have been working with schools in Ravenna to help develop English conversation skills with pupils. They now have a group of 22 thirteen-year-old Italian students looking for pen pals and exchange families in Chichester. The focus is on building links and relationships between individual families and children. The aim is to build individual pen pal relationships and grown from there.

Cllrs asked if there was any scope to build on musical and cultural links between the two cities?

Yes - Chichester University sent a group of students over last year and helped facilitate the trip, finding host families, etc, but music is tricky due to the logistics of transporting instruments etc. They are currently exploring if there is a way in which Italian students can travel over to perform here.

Chichester Tree Wardens

Paula Chatfield (Tree Wardens) had been unable to attend the meeting in person, but requested any questions be sent directly to her.

Cllrs asked if the tree wardens had been directly involved in the public realm scheme design?

The TC advised she would check with WSCC.

BID Ambassadors Report

Key themes in the City;

Lots of low value small theft – wine, food, etc from local shops – mainly due to substance abuse issues. Higher value crime in more organised groups is an ongoing issue. Roof running and Youth ASB remains an enduring problem. A few have been caught and punished, so hoping this will start to have an impact. Coop, Tesco, Boots, Iceland and TK Maxx tend to suffer most of the shoplifting; some are employing their own additional security.

Rough sleeping remains a problem – a few rough sleepers have been violent/abusive to ambassadors.

BID are expecting more police to begin patrolling the City Centre on foot from January 2026 to try and help address longstanding issues.

Cllrs asked if more CCTV coverage in the City help with some of the problems?

There are issues with CCTV quality in many of the shops, and not all the retailers report all incidents.

Pam Bushby (CDC) advised that 9 cameras in the City Centre were installed in 2022. The quality of the footage is good, but the issue is that they are not continuously monitored. Monitoring could definitely be improved. CDC had their own monitoring station in the past; this was expensive to run and ceased in 2019/20 when Sussex police took over monitoring centrally from their HQ. Continuous monitoring ceased in 2022.

Update from CDC

The local chief inspector is changing – CI Adam Craig is taking over from 1st December (transferring from Crawley). A roof running exercise has been undertaken to look at where additional security measures can be installed – most of the access is via fire escapes, so not much that can be done to prevent this. Partners are now looking at how to focus on offenders and how to reduce the number of incidents.

Graffiti seems to be an issue at the moment – post-remembrance Sunday there was a rash of swastikas etc at sites around the City. Avenue De Chartres car park remains a persistent problem, although the graffiti here tends not to be racist/fascist.

There are ongoing issues with Anti-Social Behaviour at Canon Lane/Cathedral Green. Evening patrols are still ongoing, and the outreach team are engaging with rough sleepers, plus reporting ASB, etc. This will continue until Xmas.

Support from Joint Action Group has been provided for the Belltower and the Life Group to support their youth work. Approx. 30-40 children are regularly attending their sessions.

4 e-bikes have been seized recently. Partners led by WSCC Fire & Rescue Service are launching a Junior Citizen scheme for year 6 students in Arun and Chichester (possibly hosted at Goodwood) which will cover the basics of how to be a good citizen with focus on community safety, etc.

A memorial tree for Declan Moody will be planted in Bishops Palace Gardens on Monday 24th November at 10am if anyone wishes to attend.

Cllrs asked how much was the shortfall in funding for the junior citizen event? Is this a public event?

No, it is a school and child focused event, organised with local schools. The scheme has been run in other areas around the country and data shows that it has made a positive impact on behaviour and youth engagement. An event will be held at the Council House later in the year to try and secure corporate event sponsors.

Emergency Services (and Armed Services) day will be taking place again next summer in Oaklands Park. KC confirmed that CCC will be attending again in 2026.

Community Wardens Update

Dawn had taken part in the roof running exercise to identify issues/weaknesses for properties to help secure them from roof runners.

Dawn has been doing lots of works with shops and businesses to make sure they report crime and theft incidents. Has focused on foot patrolling in the City. Work has included assisting with a number of elderly residents who have had trips and falls in the City Centre due to the state of the paving. Working well with the BID and Ambassadors and building good relationships and partnerships.

The Mayor urged members to visit the Boys Club and see the work they are doing with young people who are excluded from school/not in education and the impact that this is having. The Boys Club are still struggling with volunteers, so help needed in recruiting additional people.

Cllrs asked what is happening with regards to securing the Tannery site?

Pam Bushby advised there is some evidence that a homeless person was living there, as well as evidence that young people have been accessing it for ASB purposes. CDC are currently working with the WSCC estates team to try and secure the premises. Cllrs advised that the site is a real problem for local residents and that there are still delays on when the site will be redeveloped due to the land contamination issues.

1. Election of Chair

AGREED that Councillor Quail would be Chair of the Working Group.

2. Apologies for absence

No apologies were received.

Councillor Scicluna was absent from the meeting.

3. Declarations of interest

None were made.

4. Review of draft Terms of Reference for the Working Group

The Working Group reviewed the draft Terms of Reference.

AGREED that the Working Group would be renamed the Statuary and Public Art Working Group to broaden its remit and to possibly encourage more Councillors to join.

The CSSM agreed to redraft the Terms of Reference accordingly and also to change the statement about frequency of meetings.

5. Review of summary history of the Murray-Nelson statue to date

The Working Group reviewed and discussed the summary report that had been circulated with the agenda. It was noted that Councillor Scicluna had seen the report and made some minor factual adjustments to its content.

6. Discussion of options for future of the Murray-Nelson statue

The Working Group noted the comments about the material that had been used to produce the statue and particularly its longevity when installed in an outdoor location and also the physical damage caused by repeated acts of vandalism and any knock on effect this might have should the bronze statue ever be commissioned.

Members also noted that there were concerns regarding the wooden chainsaw sculpture in Litten Gardens and the Maurice Patten resin statue, also in Litten Gardens.

It was **AGREED** that action needed to be taken before irreparable damage was done due to exposure of the Murray-Nelson statue to the elements.

Members suggested that, since a change of ownership, the Fernleigh building in North Street, Chichester, might be amenable to having the statue located on their property as this had been the originally planned location for it. Also **NOTED** that other locations, including the Cathedral, had declined to host the statue.

Based on the City Council's Public Art Policy, Members **AGREED TO RECOMMEND** to the Property Sub-Committee that the Murray-Nelson statue be decommissioned and that, further to the public art policy, it be offered to third parties as follows:

- a) Offer to return the statue to the original artist, Vincent Gray
- b) Offer the statue to the new owners of the Fernleigh building in North Street, Chichester.
- c) Offer the statue to the Royal Navy Museum in Portsmouth
- d) Store the statue while an alternative location was identified.

The Working Group also **PROPOSED** that up to £3,000 be made available to support the removal and transport of the statue to a new location. A source of funds was not immediately identified and it was felt that agreement for this proposal would be needed from the Finance Committee.

AGREED that the City Council should retain the plinth at its current location and repurpose it for a rotating series of public art installations. Further **AGREED** that this would require work to overlay the existing wording on the front of the plinth and removal/relocation of the Sussex Heritage Award plaque from the southern face of the plinth.

Concerns were raised that it may be difficult to remove the statue itself and there may be costs involved in making good any damage caused during the process.

7. General points for future consideration

The Working Group **AGREED** that, going forward, the following needed to be considered when thinking about public art and statutory projects:

- More complete and formal record keeping and ensuring that legal and insurance concerns were addressed.
- Clearer documentation and future planning of projects, specifically when external funding was being used.
- Need to better co-ordination between the Finance and Community Affairs Committees and the Property Sub-Committee.

The Working Group **AGREED** that the group remit should extend to all existing and future City Council statutory and public art in an advisory capacity, reporting and/or making recommendations to the appropriate City Council Committees or Sub-Committees.
